PRIVACY STATEMENT

Great Plains Energy and KCP&L collect personally identifiable information from the users on our Web sites. KCP&L and its parent holding company, Great Plains Energy, are the sole owners of the information collected on greatplainsenergy.com, kcpl.com and AccountLink, on the secured portion of kcpl.com.

Registration

In order to use the secure portion of this Web site, where you can view account information and make transactions, you must first complete the registration form and create a user name and password. During registration you must provide contact information (such as name and email address). We use this information to contact you about the services on our site in which you express interest.

Log Files

As is true of most Web sites, we gather certain information automatically and store it in log files. This information includes internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and clickstream data.

We use this information to analyze trends, to administer the site, to track users' movements around the site and to gather demographic information about our user base as a whole.

We sometimes link this automatically-collected data to personally identifiable information in order to troubleshoot problems and to provide customer support assistance to users of our Web site.

Cookies

A <u>cookie</u> is a small text file that is stored on a user's computer for record-keeping purposes. We use cookies on this site. We link the information we store in cookies to personally identifiable information. We use both session ID cookies and persistent cookies. We use session cookies to make it easier for you to navigate our site. A session ID cookie expires when you close your browser. A persistent cookie remains on your hard drive for an extended period of time. You can remove persistent cookies by following directions provided in your Internet browser's "help" file.

We set a persistent cookie to give you the option to store your user ID, so you don't have to enter it more than once. Persistent cookies also enable us to track and target the interests of our users to enhance the experience on our site.

If you reject cookies, you may still use our site, but your ability to use some areas of our site, such as contests or surveys, may be limited.

E-mail Preferences

When you register for online access to our site, you have options to indicate if there are certain types of email communications you prefer not to receive. These preferences can be changed at any time through the email options screen of our AccountLink Web site. Marketing and promotional email messages from KCP&L also contain an opt-out link which you can use to indicate your preference to stop receiving such messages. Uses of Information

Information collected through our Web site is used to provide electronic alternatives to traditional contact methods such as telephone and mail. We use your personal information to establish your identity so you can receive information and make transactions through the Web site and via email.

Customer Service

We will communicate with you in response to your inquiries, to provide the services you request, and to manage your account. We will communicate with you by email or telephone, according to your preference.

Profile

We store information that we collect through cookies, log files, clear gifs, and third party sources to create a profile of your preferences. We tie your personally identifiable information to information in the profile in order to provide tailored promotions and offers and to improve the content and performance of the Web site.

We do not share your profile with third party companies or organizations other than those who are working as service providers on behalf of Great Plains Energy or KCP&L. These third parties are only permitted to use personally identifiable information for the business purposes specified by Great Plains Energy or KCP&L such as surveying, research, program promotion, and enrollment.

Information Sharing and Disclosure

<u>Aggregate Information (non-personally identifiable)</u> We share aggregated demographic information about our user base with some third party service providers. This information does not identify individual users. We do not link aggregate user data with personally identifiable information.

<u>Personally Identifiable Information</u> We never sell your personally identifiable information.

We reserve the right to disclose your personally identifiable information as required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process.
